- Students who have written the TTS test previously will not be required to take the test again, provided that the test results are still valid. The validity period for a student who has successfully completed the PGDBA and is returning to complete the MBA is five (5) years.
- Students who have already taken the GMAT, NMAT, APIL or SHL, and are in possession of valid results, may submit those results for evaluation.
